

CONDITIONS FOR USE OF FLOORS / PLANKS **VENIFLOOR** ON THE FINISHING OF UV VARNISHES AND VARNISH UV + KORUND

Producer ZIP Sp. z o. o. provides a guarantee for the stacked veneered boards **VENIFLOOR** if used in accordance with the guidelines.

Floor / boards **VENIFLOOR** is a top-class product manufactured by **ZIP Sp. z o. o** and is made of natural raw materials, it is characterized by high utility and aesthetic quality.

Before laying, floors / boards should be stored in original cardboard boxes.

1. Floors / boards **can not** be stored outdoors or in a humid place where there is a risk of getting wet. Under no circumstances should floors / boards be installed that contain any damage (e.g. a broken / broken quick-release lock, no veneer in the top layer, etc.). The temperature of use of veneered floors / boards in the room should be in the range from

18 ^{about C.} down 27 ^{about C.}

3. Relative humidity in the room should be within the range from **35%** down **65%**.
4. Before installing the boards **VENIFLOOR**, the screed or concrete floor should be heated in accordance with the "Screed heating protocol" available on www.venifloor.com. Completed and signed " *Screed heating protocol*" is an attachment to the warranty card. Lack " *Screed heating protocol*" results in the loss of the guarantee for the boards **VENIFLOOR**.
5. Information on the board assembly system **VENIFLOOR** can be found in the Installation Instructions included in each floor packaging and on the website www.venifloor.com.
6. **Care:** It is washing and applying a protective polymer micro-coating that protects the varnish layer during everyday use.

CAUTION !!! Floor care products must not be used under any circumstances **VENIFLOOR** containing silicone additives or based on silicones.

- 6.1. **First care:** The first care / maintenance of Lacquered wooden floors **VENIFLOOR** should be performed before their use, this activity is not required but recommended. Before using any of the preparations listed below, sweep or vacuum the floor. The treatment should be performed immediately after laying the floor. The boards should be cleaned with a cleaning agent for daily cleaning and care **Venix CLEAN** right after laying.
- 6.2. **Daily care:** Unbound dirt and sand should be removed on a regular basis with a vacuum or damp vacuum cleaner with a mop. For daily care, we recommend using *A cleaning agent for daily cleaning and care Venix CLEAN* (according to the application card).
- 6.3. **Periodic care:** Should be performed as needed. To carry it out Use products **Venix COVER SATIN** or **Venix COVER MATT** leaving a polymer micro-coating in accordance with the List of recommended preparations and the method of their use, which are available on the website www.venifloor.com in the bookmark " *Care and renovation*" - " *Care of varnished floors*".
7. After cleaning, do not leave wet traces on the floor, remove excess moisture with a dry cloth. Damage to the floor caused by water or other liquids is not the basis for a complaint. Under no circumstances should the veneered floor be covered
8. with PE foil or other air and moisture impermeable materials.
9. Use soft, dry or slightly damp cloths to remove dust from the floor surface. Sand or gravel applied to the floor surface should be removed immediately, as they may cause scratches on the top layer of varnish or wood and minor dents. Damage caused by the application of sand is not covered by the warranty.
10. Mechanical damage resulting from use is not covered by the warranty.
11. Any changes in the color of the wood caused by light (UV rays) are not subject to complaint. Suitable protective materials
12. should be placed under interior fittings (such as furniture, armchairs, chairs on wheels, etc.) in direct contact with the floor, e.g. felt pads with a thickness of not less than 4 mm and a width / diameter of not less than 25 mm or rugs that protect the floor against mechanical damage. Special protective mats should be placed under furniture on wheels. Shoe wipers should be placed at the entrance door.

Small stones that remain on the soles of shoes can cause minor scratches, so it is important to wipe the shoes thoroughly with the installed doormat before stepping onto the floor. A properly designed wiper system should contain **3 zones** cleaning: coarse, intermediate and drying.

In public use, the dirt collection system should be at a minimum **2.5 meters** the current cleanup string.

13. **From the beginning:** Renewal of the varnish layer after many years of use of the floor takes place through matting the wear layer (varnish) and then by applying a new layer of varnish in accordance with the technology **VENIFLOOR**. The option of renewing the floor after deep, mechanical damage is its regeneration through the use of the so-called hot hard waxes, which ideally - permanently and practically indistinguishable in terms of color - fill larger cavities. 14. The user is obliged to familiarize the cleaning staff with the conditions of use of veneered floors described above **VENIFLOOR** in finish **UV varnish** and **UV + KORUND varnish** as well as getting acquainted with the List of recommended preparations and their use are available on the website www.venifloor.com in the bookmark " *Care and renovation* "-" *Care of varnished floors* ".
15. Producer ZIP Sp. z o. o. imposes a ban on the use of mechanical cleaning devices (eg steam and pressure).
16. The manufacturer provides a warranty if the floors are used in accordance with his guidelines.
17. Failure to comply with the above recommendations results in an immediate loss of the warranty for the floor / boards **VENIFLOOR**.

CAUTION !!! It is the user's responsibility to familiarize the cleaning staff with the above-mentioned rules "Conditions for using floors **VENIFLOOR** in the finish of UV varnish or UV varnish + KORUND ".
